### **LAND AT BABRAHAM: SITE REPRESENTATION 40297**

We are pleased to submit our representation in respect of site 40297 (Land adjacent to Babraham, CB22 3AF, CB22 3AP, CB22 3AG, CB22 3AZ). This is a representation to an existing site which was promoted in the 'call for sites' process in 2019.
