Further comments Qu 1:

Completely flawed from beginning to end. Massive overdevelopment on inappropriate ruralbased site location: none of lessons of critical issues of quality-of-life post COVID 19 (C19) pandemic lockdowns etc. have been considered in ANY way.

Totally inappropriate dense development for outskirts of rural/greenbelt based Cambridge. This site is NOT central London with likes of high-rise poor quality housing dense developments & Canary Wharf-style office blocks.

Major dilution of original vision & concepts – clearly greedy Developers looking to make massive monies from dense, multistorey very high apartment blocks & office complexes. Exactly what C19 lockdowns showed as NEVER required/will never be wanted ever again.

2. Are we creating the right walking and cycling connections to the surrounding areas?

Further comments Qu 2:

People don't use methods of walk/cycle/unreliable public transport - all history tells you that. And C19 shows all public transport stops in a pandemic.

Massive effects of extra traffic in all local roads, & car parking madness on the site. All 'planning words' on 'discouraging car usage': always turn out to be unenforceable as well as inappropriate to modern ways of day-to-day living.

No consideration given massive CURRENT gridlocks with routes across Cambridge - clearly very inadequate now.

Where do you plan to put roads for everyone's (high density housing) home delivery van access?? They can't come on a bike/walking.

Total lack of any detailed strategic thought in such a proposed plan. Clearly all driven by greedy Developers looking to make massive monies from dense building initiatives, leading to major overwhelmed transport systems - but long after the Developer's diggers have upped and left.

3. Are the new 'centres' in the right place and do they include the right mix of activity? Yes, completely

Further comments Qu 3:

Science Park shows office block monoculture and thus total lack of overall mix. Post C19 pandemic situation, offices and dense housing near to them are now NEVER going to required again.

Total lack of control over Brookgate developments - no coordination with NES AAP. Local planning officers (UFOs: Unelected Planning Officers) racing ahead (to feed greedy Developers?) without any consideration to open & fair consultation with locals/City affected, & consideration of multiple ramifications to longer-term life quality in the Cambridge area. Dwellings are increasingly multi-story apartment blocks, with massive dilution of original Visions & Concepts.

Further comments Qu 4:

Clearly all driven by greedy Developers wanting to 'degrade' all green lung areas in Cambridge with horrid, dense, high-rise & poor quality housing.

(N.B. including aspects surrounding proposed move of Anglian Water's Water Treatment - not required as it has a recent upgrade: see Opposition to that Planning Application. Clear that benefits will be to Developers, not Residents or any preservation of local Green Space/Green lung/Green Belt preservation: views, environmental aspects etc.).

Planners clearly have not learnt the clear lessons of the C19 pandemic & lockdowns etc. on the critical health of the nation - especially for significant push-back on ANY dense Housing/Development areas.

No consideration to long-term massive changes to working/living practices shown during C19 lockdown.

20,000 new jobs means 40,000 more people. Housing for 18,000 noted. Maths just doesn't add up.

Clearly illustrates total lack to detailed thought of this Planning's Proposal from beginning to end.

Further comments Qu 5:

What's proposed shows thinking is based on housing the size of Ely but with facilities of Swavesey: madness !

Covers lack in all areas of key community facilities to serve such a dense housing area/community - availability of GPs & healthcare services; lack of schools planned - all ages; no swimming pool; no cultural centre; no new sports pitches; no facilities for the disabled/elderly; no new allotments; no major venue included; independent shops concept has been lost; green space by river is vague; no recognition that Milton Country Park is already at capacity etc.

Clearly all driven by greedy Developers looking to make massive monies, leaving the local 'mess' behind, long after the Developer's diggers have upped and left.

Will lead to major degradation (of already very stretched facilities) on rest of Cambridge, as well as massive increases in local travel etc. - gridlocks are ALREADY a major issue.

Where do you plan to put roads for everyone's (high density housing) home delivery van access?? They can't come on a bike/walking.

Further comments Qu 6:

Cambridge is a beautiful low density, low building height city with wonderful Green Space/Green Lung/Greenbelt areas that MUST be preserved.

High rise building developments 3 to 4 times taller than Eddington etc. will be unavoidable to the achieve the Developer's aim of 8,000 dwellings in the available land area (maths by the Developer's Proposal's/Concept Designs don't look at 3D volumes with ANY noted Height metric - we all wonder why !!).

Impact of 'layering' (effect on views/vistas/skyline from all surrounding locations) shows major impacts & severe degradation on the rural landscape of this North Eastern environs of Cambridge.

All Building Heights & Densities are definitely NOT appropriate to any Cambridge location. Clearly all driven by greedy Developers looking to make massive monies, leaving the local 'mess' behind, long after the Developer's diggers have upped and left.

Further comments Qu 7:

Clearly shows this is not enough, being too linear with too much reliance on existing. None of the massive issues of the past seen with Orchard Park have been learnt - clearly all driven by greedy Developers looking to make massive monies from very dense building initiatives, leading to major overwhelmed local systems, but long after the Developer's diggers have upped and left.

Car barns have disappeared - to give larger density of housing & even less public open space on the site.

Plan includes no new allotments; no new sports pitches; no facilities for the disabled/elderly; independent shops concept has been lost; Green Space by River Cam is very vague; no recognition that Milton Country Park already at capacity etc.

Further comments Qu 8:

Plan is completely flawed and clearly only driven by greedy Developers looking to make massive monies from very dense building initiatives, leading to major degradation of green lungs/green spaces.

Plan degrades, not maintains (even less so IMPROVES) Biodiversity. Biodiversity doubling is a regional target - 10% target is woefully low. Look at Eddington.

Specific & clear examples of major Biodiversity degradation include: no new allotments; no new sports pitches; Green Space by River Cam is very vague; no recognition that Milton Country Park already at capacity etc.

Any cycling provision is mostly squeezing more into existing 'network'.

People don't use methods of walk/cycle/unreliable public transport especially in bad weather - all history tells you that.

Massive effects of extra traffic in all local roads, & car parking madness on the site. All 'planning words' on 'discouraging car usage': always turn out to be unenforceable as well as inappropriate to modern ways of day-to-day living: school run, shift working by both parents etc. Where do you plan to put roads for everyone's (high density housing) home delivery van access?? They can't come on a bike/walking.

Includes Water conservation aspects; not Passivhaus plans; Sustainable Homes Level 6 - or 5?

No transformal step change to learn from the lessons of the past: Goldsmith Street Norwich and Eddington as models.
