Hi [REDACTED],

We should be receiving a finalised quote from the architect middle of next week. As we mentioned, a meeting on site would be useful. Can you give us dates and times that would be good for a meeting on weeks commencing 18/03 and 25/03? And we'll see if we can find a time that is suitable for everyone.

There is also another matter which I wished to raise with you. South Cambridgeshire Council is currently running a 'Call for Sites' as part of their initial preparation of a new Joint Local Plan with Cambridge City Council. We believe it will be of benefit to enter your site for consideration through this process. It will bring your site to the notice of the Council, and will reinforce your future planning application as it will demonstrate to the Council that you are serious about developing this site. Putting your site forward through the Call for Sites will also give you a fall-back position in case the planning application goes 'pear-shaped.' We will have to charge a fee of [REDACTED] to enter your site as this work was not included in our original fee proposal.
