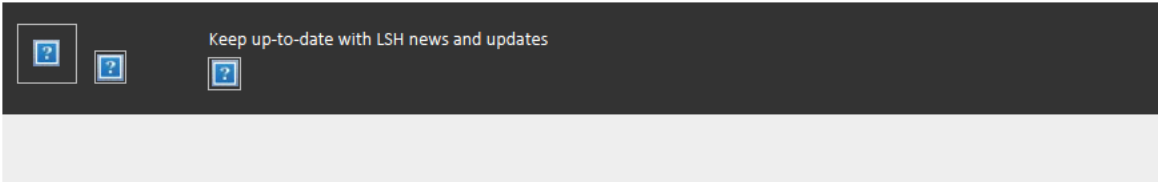

2. **Land to the south of Lanacre, Chrishall Road, Fowlmere – ref. 4046**

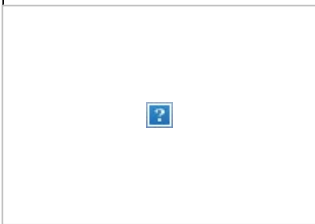
3. Land to the west of Chrishall Road, Fowlmere – ref. 40467
