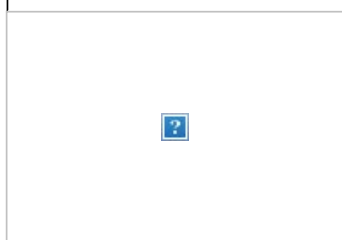

There are, however, some items missing from the HELAA response form sent to us in relation to your submission for **Land off Home End, Fulbourn**.

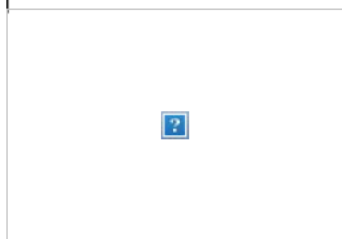
Accordingly, please now supply the following information and return it to us, **within the next ten working days**:
